




Preservation and Restoration of Library **Collections from Fire** 

Nora H Jason. National Institute of Standard and Technology, Gaithersburg, Maryland, U. One of the roles of library collections is to preserve and protect the universal knowledg from natural and unnatural disasters whether they be housed in large copyright libraries (e.g., the Library of Congress in the United States), or in small secialised collections (e.c the Fire Research Information Services). The first step is to develop a plan of action before there is an earthquake, fire or other type of disaster. A disaster plan includes but is not limited to fire protection systems, fire department activity, and management and staff responsibilities. Rehabilitation of items exposed to excessive water and/or smoke damage will be highlighted. The elements that such a plan should include will be discussed together with appropriate response.
